


4. Potential Revenue Indications for you

Under GW License Rights, the treatment is suited -

- for creating a new home clinic,
- for a new or existing mobile service
- as an add-on new service for an existing business such as a massage therapist, reflexologist, reiki, aromatherapy, spa, hairdressing, or beauty salon.

The GW Licensee would have the advantage of -

- Being able to call their business a GW Facial Therapy® clinic or service.
- There will only be one licensed clinic located in each suburb or town
- work your own hours
- use the proven brand GW Facial Therapy®
- have the ongoing support of the GW Resource Library
- Anna will provide new techniques in video format from time to time for the GW Resource Library
- A proven hourly rate of \$110 an hour



Potential income estimates

Despite challenging financial downturns, it appears that women are always willing to invest in self-care, particularly when it comes to beauty, health, and wellness, which are GW's focus areas.

GW therapists working from home can anticipate earning \$110 per hour for a GW treatment. Each therapist will likely have different strategies, with some choosing to work only a few hours a week and others more. Some therapists already operating as a business may just add the GW Facial Therapy treatment or techniques to other services they may offer. If you have a shopping centre type beauty or hair salon you could charge more. Gift Vouchers and smaller ancillary profits from skincare product sales will further augment this income. GW imposes no restrictions as to what products you may sell. You will be able to buy GW skincare products wholesale with a small minimum buy of \$150.

There are no guarantees, but it could be reasonably assumed that a successful Home Clinic, mobile therapist or salon therapist working part-time, providing one facial treatment a day, averaging 5 hours a week, could earn an extra \$2,200 monthly. We exclude product sales profits from this calculation. These revenues would undoubtedly be a welcome and significant addition to most household incomes.

6. Secure the License Rights to your suburb or town



The GW Facial Therapy® License Rights can be purchased to start a new business or to add new services to an existing business.

Summary

GW Facial Therapy® offers a unique opportunity to lead the beauty, health, and wellness market in your area. With established expertise, proven part-time work at \$110 an hour, effective techniques, good demand, great feedback, multiple trademarks, and comprehensive training with support materials, GW has everything you need for success. The groundwork is laid for you to capitalise on this unique opportunity.

Your GW Facial Therapy® Licensing Rights

- Your GW Facial Therapy Clinic: The License rights allow you to describe your business as a GW Facial Therapy® Clinic or GW Facial Therapy® Mobile Service. Refer to the treatment as GW Facial Therapy® and become a GW Facial Therapist.
- Your Allocated Area: Secure the GW Facial Therapy intellectual property rights for your suburb or town for your new GW Facial Therapy® Clinic or where your existing business is operating from. Only one License will be made available for each allocated area. At our discretion a Licensee once established and trained, upon request may be allocated an adjoining suburb (if available) for an additional payment.
- **Experience**: No experience or qualifications are needed. Anna will train you from scratch. All you need is a caring attitude and a willingness to learn a natural treatment.

Training Choices:

Your License payment includes either -

- a) Online video training with a final one-on-one zoom fine-tuning one and a half hour session with Anna OR
- b) two days of in-person training with our Master Facial Therapist, Anna, at her home in Brisbane (with a maximum of four GW Licensees).

You will be provided with a GW Certificate and ongoing online access to the GW Resource Library. We have proven with the supporting GW Resource Library available for reference purposes, a GW therapist can be trained effectively online at their own

pace or in-person over two days.

- New Techniques: Anna will add new training videos and techniques to your GW Resource Library from time to time.
- Advertising: We recommend you use social media on your local community page to kick-start your client list.
- **GW Skincare**: GW Skincare products will be available at wholesale prices for use with the treatment and for retail sales to your clients.
- **IP Licensing Rights Term:** The Licensing Rights continue as long as you make the monthly payment commitments on time. Our website payment system refers to these monthly payments as a 'subscription' but the monthly payment required is to hold your License Rights and your suburb.
- Cancellation of IP License Rights: You can cancel the monthly 'subscription'
 anytime and lose your IP License rights; your allocated suburb or town may then be
 assigned to someone else.
- **Ongoing Support:** The GW Resource Library provides ongoing support with comprehensive illustrated PDFs and videos on facial treatments and techniques, which Anna will update from time to time.



- Your Freedom to Choose: Unlike a franchise, the License is a tiny fraction of the price and allows you to operate how you want. You can work the hours and days you want to work. Within your allocated area, you can operate from home, through a mobile service, or through a hairdressing salon, spa, or beauty salon. This proposal is suited to a new or existing therapist. You can trade under your own name or business name and provide GW as a sole service or add it to existing services. You can also sell non-GW products alongside GW skincare products purchased at wholesale prices if you wish to.
- Trademarks: As a Licensee, you can use the GW Facial Therapy® and GW Japanese Facial Rejuvenation® trademarks and the GW treatments and techniques.
- Professional Indemnity Insurance: The Licensed therapist can apply for the service to be added to their existing professional indemnity insurance. An alternative would be the IICT. The IICT recognises the modality GW Facial Therapy and the GW

Japanese Facial Rejuvenation treatment in 35 countries. If you don't already have PI Insurance or membership with the IICT, you can upgrade your GW Certificate to a Gorgeous Woman Japanese Facial Rejuvenation Certificate and apply to the IICT for professional indemnity insurance through their Insurance partner. This is a simple process. Please see the steps in your GW Resource Library.



7. How to proceed...

There are three simple steps:

 Firstly, you will need to check with GW Support to see if your suburb/town is still available for your preferred License allocated area. You can do this by completing the support form at www.gwfacialtherapy.com/check-availability



We usually respond the same day.

- 2. If your suburb/town is available, you can then take advantage of our current early bird offer to secure and hold your GW Facial Therapy® License for \$2,200 and \$220 a month. This covers your online or in-person training, allocation of your suburb/town, the use of trademarks GW Facial Therapy® clinic or service, the use of the treatments and techniques and ongoing access to the exclusive GW Resource Library. Note: the \$220 monthly is referred to by the online system as a subscription but it is really the payment required to hold your License rights and suburb. - 3. After purchasing your GW Facial Therapy® License, you can commence online training or if you prefer you will be invited to a two-day training session with our founder and Master Facial Therapist, Anna, at her home in Brisbane. For the in-person training You will have a choice of dates to find a time that suits you. The training date can be deferred if needed to suit your business plans.
